Petroleum Engineering	Average SFR is more than 20:1 i.e, 21.5:1. Therefore, the program does not meet the essential parameter of 6 years of accreditation. Hence, accredited for 3 years. Marks are recalculated as per formula in SFR and reduced from 786 awarded by the Visiting Team to 782.
